

# *Yvonne's Bichons*

## Sales Contract For a Companion/Pet Puppy

This contract is entered into between **YVONNE'S BICHONS** - Yvonne Hanna (hereinafter "SELLER") and \_\_\_\_\_ (hereinafter "BUYER").

### BUYER AND SELLER AGREE TO THE FOLLOWING PROVISIONS OF THE SALE:

**SELLER** makes the following assertion at the time of **BUYER** taking possession of the **PUPPY**:

This **PUPPY** is the offspring of AKC registered parents. The pedigree is correct and given at the time of sale. The **PUPPY** can be registered with the AKC (American Kennel Club) on *Limited* terms as indicated.

The **PUPPY** is in good health, free from known contagious diseases and has had vaccinations/worming required for its age at the time of this agreement.

**BUYER** agrees that since this **PUPPY** is sold as a *Companion or Pet Quality PUPPY* that they are in agreement to spay/neuter their **PUPPY** no later than the age of six months. **SELLER** may hold AKC registration papers pending receipt of proof of spaying/neutering. Should the **PUPPY** be bred for any reason (even if sold to another party), **SELLER** reserves the right to take legal action against the **BUYER**. All legal and court fee's on both the **SELLER** and the **BUYERS** behalf will be the responsibility of the **BUYER** and all legal proceedings will take place in the city of Knoxville, in the state of Tennessee.

**BUYER** agrees to have the **PUPPY** examined by a licensed veterinarian within 48 hours (not including Sundays or holidays) from the time that you or your agent receives the **PUPPY**. If the veterinarian finds a health condition or defect that would make the **PUPPY** unsuitable for a pet, the **PUPPY** and a written statement from your veterinarian (stating the problem) must be returned to the **SELLER** immediately. **BUYER** can elect to keep the **PUPPY**, assuming all costs for its care or you may choose to return the puppy for another **PUPPY** of equal quality or better if available or a refund of the purchase price. **SELLER** must receive a written statement from your veterinarian regarding the **PUPPY'S** health before any of the above provisions can take place. **SELLER** reserves the right to have a second opinion from a veterinarian of her choice to check the **PUPPY'S** condition before replacing the **PUPPY** or refunding the purchase price. These provisions will expire 48 hours (not including Sundays or holidays) after **BUYER** or agent takes possession of the **PUPPY**. Should you not take your **PUPPY** for its examination, you will assume full responsibility for its health.

**BUYER** certifies, by signing this agreement, that the **PUPPY** will live with the **BUYER** as a housedog, will not be left outside unsupervised, will be taken to a licensed veterinarian, including all puppy shots and anything else that might happen with the **PUPPY**. **BUYER** will not resell this **PUPPY** to a pet store or medical facility.

**SELLER** guarantees the **PUPPY** against any inheritable/genetic defects for one year from date of birth. **SELLER** makes no guarantees regarding loss of the **PUPPY** because of accidental death, sickness, etc. or any other loss beyond **SELLER'S** control, except as stated above. If the **PUPPY** develops any inheritable/genetic defect within twelve months from the date of birth, **BUYER** may return the **PUPPY** to **SELLER** for a replacement **PUPPY** of equal or better quality if available, selected by the **SELLER**, if and when the **SELLER** has the next litter of puppies. **SELLER** reserves the right to have a second opinion from a veterinarian of her choice to check the **PUPPY'S** condition before the warranty is honored.

**BUYER** agrees to pay **SELLER** on possession of the **PUPPY**, or if it is being shipped, one week prior to shipment date. Payment may be made one of three ways, (1) Cash, (2) Postal Money Order, (3) Credit Card via [www.paypal.com](http://www.paypal.com).

This Sales Contract is non-transferable. Should **BUYER** relinquish ownership of the **PUPPY**, for any reason, this Sales Contract shall be deemed null and void. The **BUYER** understands and accepts the terms of this contract by his/her signature.

**SHOW POTENTIAL:** is defined as a **PUPPY** that has the potential to be shown. This **PUPPY** is free from any disqualifying faults at maturity as determined by the breed standard. **SELLER** does not guarantee that the **PUPPY** will attain a *Championship* or *Title* if shown in the confirmation ring. **SELLER** does not guarantee that the **PUPPY** will keep with breed standards.

**BREED POTENTIAL:** is defined as a **PUPPY** who has the potential to develop into a good mother and to make the breed better. **SELLER** does not guarantee that the offspring will have all the breeds' standards.

**COMPANION/PET QUALITY:** is defined as a **PUPPY** that *may* have a disqualifying fault and or other short comings that prevent the **PUPPY** from showing and breeding or the **PUPPY** may be of show quality but is registered with the AKC with a *Limited Registration*. Said **PUPPY** is other wise normal and healthy, these **PUPPY'S** are spayed or neutered. The spay/neuter must be completed no later than six months of age. **SELLER** will hold AKC papers until **BUYER** shows proof that he/she did indeed spay/neuter the **PUPPY**.
